

## REQUISITE DOCUMENTS FOR POINTS BASED TIER 1 (ENTREPRENEUR) MIGRANT VISA

**Bold Items are essential.** We advise applicants that the failure to submit such documentation **may result in refusal of the application**, as the **onus is on the applicant to demonstrate** that they meet the requirements of the relevant rules. The ECO's decision will be made on the basis of the evidence supplied. It is paramount that ECO's understand the reasons for your application as well as your personal circumstances. All documents submitted as evidence of points claimed **must** be submitted in their **original format** and **must be supported by notarised translations.** Checklist:

<b>4. One recent passport-sized photographs -</b> not scanned copies - (photographs must have white background and must be glued to the application form)			
5. A copy of pages 1 to 4 of your current passport			
6. The Correct fee in Turkish Lira only			

To qualify, you must be able to show evidence for the following:

IF POINTS ARE BEING CLAIMED UNDER ANY OF THE ATTRIBUTES AND CONTROLS THEN		
DOCUMENTS MUST BE SUBMITTED TO SUPPORT THE AWARD OF THE POINTS CLAIMED. YOU		
MUST ALSO SUBMIT YOUR SELF-ASSESSMENT SUMMARY OBTAINED FROM THE POINTS BASED		
CALCULATOR. All documents must be original and supported by original notarised translations with		
copies		
7. You have at least £200,000 and must provide an original letter confirming the amount of funds		
available from each financial institution holding these funds.		
8. You must provide evidence that the institution holding the funds is a regulated financial institution		
regulated by the official financial regulatory body in the country of operation where the transaction was made.		
9. Evidence must be provided that the funds are disposable in the UK either by showing that the funds are held		
in the UK in an institution regulated by the Financial Services Authority (FSA) and have been held		
there for less than 12 months or that they are freely transferable to the UK and convertible to pounds

<b>10.</b> If you are relying on third party support (includes funds held by partner/spouse) you must provide a		
declaration from every third party contributor detailing what funds are available to the applicant,
